TODDLER CONTRACT (UNDER 3 YEARS OLD)

This agreement is made and entered into between Dynamite Montessori, Inc., hereinafter known as the "School," and _____, hereinafter known as the "Parents." Parents contact information: Email: _____

The School hereby accepts _____ as a pupil for the school year August 1, 2018 through May 24, 2019. Pupils are enrolled for the entire school year or for the remainder of a school year if enrolled after the opening date.

Pro-rated allowances will be made if the child is accepted after the first week of the school year. Monthly tuition payments will remain the same for the school year. Tuition payments for the first month and last month are due in full before first day of attendance. **If a pupil is withdrawn before the end of the school year, the last month pre-paid tuition deposit will be forfeited.** The School reserves the right to terminate this contract if the Parents fail to keep their financial obligations or if the child's behavior warrants such action, or if parents are not supportive of the policies of Dynamite Montessori. This contract is for the entire school year or pro-rated for late entry. Monthly payments are in place as a convenience to our parent-body. Discounts are available for pre-payment of tuition.

Tuition rates are as follows:

- 3 half days 8-Noon: Tuition is \$5,350/school year divided into payments of \$535/month
- 3 full days 8-4: Tuition is \$6,850/school year divided into payments of \$685/month
- 4 half days 8-Noon: Tuition is \$6,350/school year divided into payments of \$635/month
- 4 full days 8-4: Tuition is \$7,850/school year divided into payments of \$785/month
- 5 half days 8-Noon: Tuition is \$7,350/school year divided into payments of \$735/month
- 5 full days 8-4: Tuition is \$8,850/school year divided into payments of \$885/month
- A one-time, non-refundable registration fee of \$100.00 is required.
- First and last month's tuition is due upon enrollment
- Any child picked up after their designated pick up time will be charged a \$25.00 late pick-up fee
- There will be a \$55 flat rate daily drop in fee. This "drop in day" is completely contingent on our spot availability that day and will be allowed on a first come first serve basis. ANY drop in days MUST be pre-approved by the office administrator
- Siblings enrolled concurrently, **full day-five days a week**, will receive a 10% discount
- Tuition is due by the 1st of the month and considered late after the 5th day of the month. A late fee of \$50.00 will be charged if tuition is paid after the 5th
- No tuition shall be refunded due to the child's absence from school, holidays, teacher in-service days or school breaks
- Daycare is available for full day toddlers from 4:00-5:30pm at \$10.00/hour
- A \$25.00 charge will be assessed for late pickup (after 5:30)
- \$10 fee for Transparent Classroom (To Be Confirmed) in addition to a \$30 accreditation/license fee

One security gate card will be supplied to each parent, free of charge. Replacement or additional gate cards can be purchased for \$25.00 each. At such time as the child is no longer in attendance at Dynamite Montessori the provided gate cards should be returned to the school.

DMS follows the Cave Creek Unified School District (CCUSD) calendar for winter and spring breaks. Please refer to the school calendar on our web-site at <http://www.DynamiteMontessori.com>.

A parent, relative or friend is required to come in to help for the following events: World Peace Day, Halloween, Thanksgiving and Winter Festival.

E-mail is the primary means of communication between the school and parents. Parents agree to regularly check and participate in e-mail communication with the school.

New parents agree to attend a 2.5 hour workshop on Sat. Aug 18, 2018 from 9:00 AM to 11:30 PM. Also, a mandatory general meeting for all toddler parents will be held on Aug 8, 2018 from 4:15 to 5:00 PM.

All new and returning parents are expected to attend a conference with the teacher once/semester and as many parent education meetings as possible.

The School reserves the right to terminate this contract if the Parents fail to fulfill their financial obligations; the child's attendance becomes irregular; or, in the sole judgment of School management, either the Parents or the child become a disruption to the School's education and administrative processes or a threat to the emotional or physical well-being of others.

When the child turns 3 and is potty-trained he/she may enter a primary class of the school's choosing.
