## PRIMARY CONTRACT (3-6 YEAR OLDS)

This agreement is made and entered into between Dynamite Montessori, Inc., hereinafter known as the "School," and

The School hereby accepts \_\_\_\_\_ as a pupil for the school year August 1, 2018 through May 24, 2019. Pupils are enrolled for the entire school year or for the remainder of a school year if enrolled after the opening date.

Pro-rated allowances will be made if the child is accepted after the first week of the school year. Monthly tuition payments will remain the same for the school year. Tuition for the first month and last month is due in full before first day of attendance. **If a pupil is withdrawn before the end of the school year, the last month pre-paid tuition deposit will be forfeited.** The School reserves the right to terminate this contract if the Parents fail to keep their financial obligations, if the child's behavior warrants such action, or if parents are not supportive of the policies of Dynamite Montessori. If parents dis-enroll their child due to a move more than 10 miles away from our school the last month's pre-paid tuition may be refunded. This contract is for the entire school year or pro-rated for late entry. Monthly payments are in place as a convenience to our parent-body. Discounts are available for pre-payment of tuition.

Tuition rates are as follows: Monday through Friday

- Full Day schedule 8:00 am to 4:00 pm - Tuition is \$7,850/school year divided into payments of \$785.00/month
- Half Day schedule 8:00 am to 1:00 pm - Tuition is \$6,850/school year divided into payments of \$685.00/per month
- Daycare is available from 7:30-8:00am and 4:00-5:30pm at \$10.00/hour
- A \$25.00 charge will be assessed for late pickup (after 5:30)
- Siblings enrolled concurrently, **full day – five days a week**, will receive a 10% discount
- One time, non-refundable registration fee of \$100.00
- Annual AMI membership fee and AZ licensing fee of \$30.00
- First and last month's tuition is due upon enrollment
- \$10 fee for Transparent Classroom access

Tuition includes Spanish instruction.

Special classes are available after school for additional fees.

Tuition is due by the 1<sup>st</sup> of the month and considered late after the 5<sup>th</sup> day of the month. A late fee of \$50.00 will be charged if tuition is paid after the 5<sup>th</sup>. No tuition shall be refunded due to the child's absence from school, holidays, teacher in-service days or school breaks. DMS follows the Cave Creek Unified School District calendar for winter and spring break. Please refer to the school calendar on our web-site at <http://www.DynamiteMontessori.com>.

One security gate card will be supplied to each parent, free of charge. Replacement or additional gate cards can be purchased for \$25.00 each. At such time as the child is no longer in attendance at Dynamite Montessori the provided gate cards should be returned to the school.

Parents are responsible for checking their child's cubbies each week and taking work home, and checking their e-mail, which is the primary means of communication between the school and parents. New parents agree to attend a 2.5 hour Saturday workshop on August 18, 2018 from 9 AM to 11:30 PM. Parents are also required to attend one parent-teacher conference with a prior observation and one parent education each semester.

New parents agree to attend our first general meeting on August 15th from 4:15 to 5:00 PM. We will discuss policies, philosophy, curriculum, events and start the community building process anew.

Parents understand that the primary program is a **3 year cycle** and intend to keep their child at Dynamite Montessori through the kindergarten year.

The School reserves the right to terminate this contract if the Parents fail to fulfill their financial obligations; the child's attendance becomes irregular; or, in the sole judgment of School management, either the Parents or the child become a disruption to the School's education and administrative processes or a threat to the emotional or physical well-being of others.
